## Convert your Air Liquide shares to directly registered form

### Your shares are in a bearer or administered registered form

It is up to you to initiate the request to convert your Air Liquide shares to directly registered form with your financial institution.

1. Complete the directly registered share transfer form on the back.
2. Send the form to your financial institution<sup>(a)</sup>. It will perform the operation and inform Air Liquide's Shareholder Services, which will then send an account agreement to you. You will need to return it to Shareholder Services with the requested documents to finalize the opening of your account.



### THE ADVANTAGE LOYALTY REWARDED

By holding your shares in registered form, your loyalty is rewarded! After holding your shares in registered form for two full calendar years, you receive **+10%** on the amount of dividends received and on the number of bonus shares that you receive when they are issued.



**Receive the loyalty bonus starting in 2024 by converting your shares before the end of 2021. Check with your financial institution for possible bank charges. If bank charges are applied, reduce them by making a request for one-time conversion with your financial institution.**
