- **does not entitle the Representative to pay for the purchase of shares.**

ADMINISTRATIVE DETAILS

2. Attach the following documents:

(a) For new share accounts

- the share account agreement,
- all the supporting documents requested in the administrative details of the agreement
- a photocopy of proof of address of the Representative* (electricity, landline phone, gas, water, Internet, etc. bill) only if the Representative is the recipient of any information regarding the share account.

** For a split-ownership account, the representative is appointed by the other joint holders of the share account and signatories of this document.*

(b) For existing accounts

- a photocopy of both sides of an identification document of the joint signatory(ies) of the proxy
- a photocopy of proof of address (electricity, landline phone, gas, water, Internet, etc. bill), only for the Representative.

(c) For accounts held by minors

Once the shareholder reaches the age of majority, the account holder is no longer under the responsibility of a legal representative.

Any proxy signed by this representative will therefore become invalid.

To update the shareholder's share account, Shareholder Services will send the account holder who has reached the age of majority a share account agreement, in the holder's name only, to be completed. If desired, the holder may attach a new proxy form and select a representative.
