**Accordingly:**

- **Sign all** documents, receipts, or discharges and generally do what is necessary for all routine transactions relating to the Air Liquide securities that may require my signature;
- **Give the Representative** the ability to import my account. The representative will then have exclusive access to my online Shareholder Portal via his or her own online Personal Portal in order to carry out the transactions indicated above in accordance with the general terms and conditions of the new account agreement signed by me. **This access by the Representative no longer allows me to have access to my Shareholder Portal. In other words, access to my Shareholder Portal will now be possible only using the Representative’s login credentials;**
- **Authorize the Air Liquide Shareholder Services Department** to carry out these transactions in accordance with the general terms and conditions of the account agreement signed by me;
- **Do not entitle the Representative to pay for the purchase of securities.**

The Principal may terminate this power of attorney at any time by informing the Shareholder Services Department by any means. The Representative may also renounce this power of attorney at any time and must then inform the Air Liquide Shareholder Services Department and the Principal by any means. The death or incapacity of one of the parties also terminates the power of attorney.

## ADMINISTRATIVE DETAILS

### 1. Complete and sign this power of attorney form

### 2. Attach the following documents:

#### For the opening of a security account or its regularization:

- the security account agreement;
- all the supporting documents requested in the administrative details of the agreement;
- a copy of proof of address of the Representative\* (electricity, landline phone, gas, water, Internet, etc. bill) only if the Representative is the recipient of any information regarding the security account.

\* For a split-ownership account, the Representative is appointed by the other joint holders of the security account and signatories of this document.

#### For existing accounts

- a copy of both sides of an identification document of the joint signatory(ies) of the power of attorney;
- a copy of proof of address (**preferably a copy of your mobile phone bill**; otherwise, your bill for electricity, landline phone, gas, water, Internet, etc.) only for the Representative.

#### For accounts held by minors

Once the shareholder reaches the age of majority, the account holder is no longer under the responsibility of a legal representative.

The power of attorney signed by the legal representative will therefore lapse.

To update the shareholder's security account, the Shareholder Services Department will send the account holder who has reached the age of majority a new security account agreement to be completed. If desired, the holder may attach a new power of attorney form and select a representative.
