The Air Liquide site is partially compliant with RGAA 4.1 Double-A (AA) level due to the non-conformities and deviations listed below.

The compliance audit carried out by [Ipedis](#) reveals that the compliance rate is 80,88%:

- 55 compliant criteria
- 13 non-compliant criteria
- 38 non-applicable criteria

Non-compliance

Several elements of non-compliance are described in this document, some of which are recurrent on several pages:
